The organization's research department evaluates each candidate based on these 12 indicators of peer recognition and professional achievement: verdicts and settlements; transactions; representative clients; experience; honors and awards; special licenses and certifications; position within law firm; bar and or other professional activity; pro bono and community service as a lawyer; scholarly lectures and writings; education and employment background; and other outstanding achievements. While up to five percent of the lawyers in the state are named to Super Lawyers, no more than 2.5 percent are named to the Rising Stars list.

Edward J. Ciarimboli received a dual bachelor's degree from Wilkes University in Engineering and Political Science, and received his law degree from Duquesne University School of Law. Ciarimboli served as a law clerk to Luzerne County Court of Common Pleas and the U.S. District Court for the Middle District of Pennsylvania. In 2005, Attorney Ciarimboli joined Attorney Fellerman's private practice as a partner and focuses his practice on achieving justice for the injured and has successfully represented victims of automobile collisions, defective products, medical negligence, trucking catastrophes, premises liability accidents, and insurance bad faith claims.

In addition to his civil practice, Attorney Ciarimboli currently serves as the Solicitor for Luzerne County for the Mental Health/Mental Retardation Program and is an ARC Board member. He is a member of the Luzerne County Bar Association, the Pennsylvania Bar Association, the Pennsylvania Association for
